

2017 Common Alerting Protocol (CAP) Implementation Workshop 20-21 September 2017 in Rome, Italy

The 2017 Common Alerting Protocol (CAP) Implementation Workshop will be held 20-21 September 2017, in Rome, Italy. It is hosted by the Fire Corps Academy of Italy, Istituto Superiore Antincendi.



A CAP Training Session is offered in the same venue on the day before (19 September).

An EDXL Workshop is offered 8:30 to 12:30 in the same venue on the day after (22 September).

Everyone interested in emergency alerting is welcome: managers, technical staff, media, etc., including those in government, non-governmental organizations (NGOs), and commercial organizations. There is no charge to participate.

The Workshop this year is co-sponsored by the [International Association of Emergency Managers \(IAEM\)](#), the [International Federation of Red Cross and Red Crescent Societies \(IFRC\)](#), the [International Telecommunication Union \(ITU\)](#), the [OASIS](#) standards organization and the [World Meteorological Organization \(WMO\)](#). These Workshops focus on emergency alerting as enabled by the CAP standard, ITU-T Recommendation X.1303. At the Workshops, implementers of CAP and other associated organizations discuss common issues and how best to expand adoption of CAP.

The CAP Training Session covers: understanding CAP and how it serves interoperability; getting and displaying CAP alerts from alerting authorities and aggregators; making and validating CAP; and, disseminating CAP via traditional methods, the Internet, and new media. A survey of other CAP implementations now underway or newly launched, as well as new developments in some of the existing CAP implementations is included (see status report: [CAP Implementation by Country](#)). Also, the CAP Training Session includes hands-on installation of a free tool for creating and publishing CAP alerts.

There will be about 30 presentations at the Workshop, on a wide range of topics and presented by experts from every part of the world.

Italy's National Fire Corps will present on its progress in implementing CAP in support of their mission throughout Italy. This will include a focus on adopting CAP in nation-wide rescue services. A separate presentation will address how Can CAP help persons with disabilities calling for rescue or receiving public alerts. Also, managers

involved in Civil Protection for Italy will also present on the successful expansion of CAP use.

Cloud Services and CAP-based Alerting will be addressed by an Amazon Web Services manager.

IFRC will present on the new 'What Now' service being developed in partnership with Google. This is a data feed that is designed to be paired with CAP alerts--providing a trusted set of content with key actions to improve early action amongst those on the receiving end of alerts.

AccuWeather will present about its use of CAP. AccuWeather apps and partner apps reach 1.5 billion people globally, in over 100 languages. Accuweather integrates publicly available warnings from the governments of over 50 countries, many using CAP.

Météo France will introduce its new CAP-based WINTDO (What I need to Do) Toolkit. There will also be a presentation on disseminating CAP alerts generated from satellite-based fire detection.

Another of the presentations will describe China's National Early Warning Release Center. Established in 2015, the Center studies and formulates relevant policies and technical standards. It is mainly responsible for construction, operation and maintenance of China's National Early Warning Release System (NEWRS). This operational and very large scale, CAP-based system provides the overall release channel for relevant departments throughout China to disseminate and publicize early warnings and related information for all types of hazards.

The German Weather Service, Deutscher Wetterdienst (DWD), will present an update on its implementation of CAP. DWD has leveraged CAP for many years and recently added CAP feeds and English warnings to its portfolio. DWD will also share some insights on the use of CAP in support of push-enabled applications.

The German Aerospace Center (DLR) will present its Project on a Multi-Hazard Open Platform for Satellite Based Downstream Services (PHAROS), which has a CAP alerting component.

A presentation on CAP in Norway will focus on cooperation between MET Norway and the Norwegian Broadcasting Company. An update on CAP in Mexico will be a presentation topic. The implementation of CAP in Botswana will be presented, and another presentation will describe

CAP implementation in the Democratic Republic of the Congo. There will be a presentation by Zimbabwe on CAP implementation and related activities there, as well.

Sahana Software Foundation will present on work concerning the use of symbols in communicating emergency alerts. Also, there are a number of CAP implementations operational or in progress that use Sahana Software Foundation tools.

The ITU Development Bureau will deliver a presentation on its role in CAP implementation and measurement worldwide.

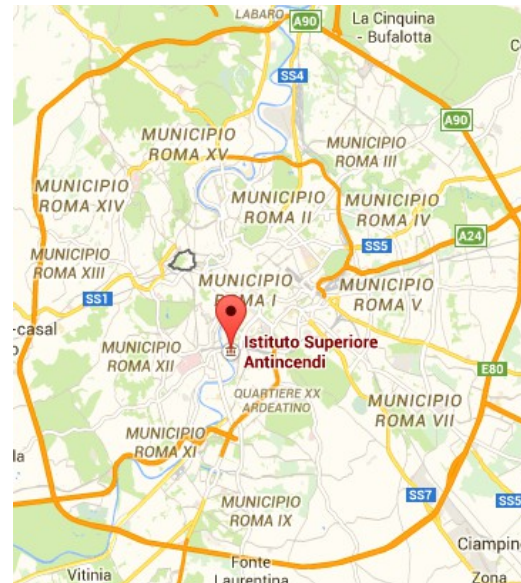
CAP "alert hubs" will be a topic again this year. An alert hub simplifies access to copies of alerts by aggregating alerts from many different feeds into one URL. There will be an update on the "Filtered Alert Hub" (see <http://alert-hub.org>). This free and open source software filters available CAP alerts by city or country, and any other alert content. The Filtered Alert Hub technology also supports the "WMO Alert Hub" prototype. This will be a major component of the Global Multi-hazard Alert System (GMAS) now being realized in WMO.

Participants will hear from the [OASIS Emergency Management Technical Committee \(EM TC\)](#) about efforts to seek consensus on common CAP "event" terms and criteria to distinguish those highest priority CAP alerts that should be sent immediately to all people in an affected area. During the CAP Workshop, the OASIS EM TC will meet with its usual call-in arrangements.

On 22 September, a half-day workshop will present the OASIS Standards that support the emergency management mission, focusing on Emergency Management Emergency Data Exchange Language (EDXL) standards along with the reference information model and tools available. There will be also presentations of how EDXL is being used in operational systems. Details are at the [EDXL session website](#).

The CAP Workshops are technical meetings conducted in English without interpretation. These meetings do not set policy; they are intended solely for information sharing among experts. Accordingly, participants represent themselves and need not be formally associated with organizations. Registration is strongly encouraged for administrative and planning purposes. Participants from a WMO Member agency should note the [WMO invitation Letter](#). (WMO is not able to provide travel funding this year, regrettably.)
